- The right to object to the processing of data allows the user, in certain circumstances provided by the applicable law, to oppose the processing of personal data concerning him
- The right to erasure allows the user to obtain the erasure of data without undue delay (for example, when personal data are no longer necessary for the purpose for which they were collected), subject to the exceptions provided for by the applicable legislation (for example, when the storage of data is necessary in order to comply with the legal obligations applicable to the controller);
- The right to restriction of processing allows the user, in certain circumstances provided for by the applicable legislation, to restrict the processing of their personal data. In such cases, Salvimar may continue to process your data, but only in certain circumstances, for example in order to exercise its right of defence and to protect the rights of other natural or legal persons;
