

COOKIE POLICY

According to current legislation, the use of cookies requires your express consent. However, "technical cookies", that is those used for the sole purpose of transmitting a communication on an electronic communication network, do not require such consent, or to the extent strictly necessary to provide a service explicitly requested by the user. In other words, these cookies are essential for the operation of the site or necessary to perform activities requested by the user. Similar to the above technical cookies, which therefore do not require express consent for their use, are also "performance cookies" when used directly by the site operator (cd. "first party cookies" or "owners") to collect information in aggregate form on the number of users and how they visit the site itself - or, where they are provided by third parties, if appropriate tools are adopted to reduce the power of identification (for example, by masking significant portions of the IP address) - and "functionality cookies", which allow the user to navigate according to a number of selected criteria (for example, language, products selected for purchase) in order to improve the service rendered to the same. The use of these cookies has also been set so that the provider (Google) uses them exclusively for the provision of the service and stores them separately and does not "enrich" or "cross" with other information at its disposal, unless specific consent.

MANAGEMENT OF COOKIES BY BROWSER

In compliance with minimum security measures, the data deriving from the use of cookies may also be disclosed to public security entities and other public and private entities for the fulfillment of legal obligations including tax, administrative, financial and similar. In no case will the data be disseminated.

In compliance with the principles of proportionality and necessity, the data will not be stored for longer than those essential for the achievement of the purposes indicated above and, therefore, the service offered or the specific legal rules. At any time the user can exercise his access rights against the Data Controller, pursuant to article 15 of EU Regulation 2016/679. In addition, you have the right to obtain the updating, rectification, integration and deletion of data or restriction of processing. Finally, you have the right to object, in whole or in part, for legitimate reasons, to the processing of your personal data.
